### **January 31:**

- Go to [www.mybpta.org/neara](http://www.mybpta.org/neara) to nominate yourself or someone else to attend the NEA RA as a local delegate this summer.
- If you cannot use the webpage or would like to fill out a paper nomination form, you may reach the NOCUT office staff at the phone number or address listed on this letterhead and they will assist you.

### **February 14:**

- Declaration of candidacy webpage closes.

### **February 24 – March 6:**

- Materials shall be distributed to sites by the association Elections Chair or Chapter Leadership.

### **March 9 – 13:**

- Voting is to take place at school sites/work locations.

### **March 13:**

- All materials to be delivered to the NOCUT office no later than 4:00 PM.

### **March 16:**

- Elections Committees will count association ballots at NOCUT office.

### **March 17:**

- Local election results announced.

### 2020 NEA-RA STATE DELEGATE ELECTION TIMELINE

<b>12/18/19 – 1/31/20</b>	Declaration of Candidacy Forms printed in the California Educator and posted on the CTA website. (Declaration of Candidacy forms available at the Orange RRC for State Delegate candidates, upon request.)
<b>1/31/20 5:00 p.m.</b>	Deadline for Service Center Council to receive State Delegate declaration of candidacy forms.  Declaration of Candidacy forms for State Delegate to be returned to the Orange RRC.  <b>Deadline for request of state ballots, biographies, and other election materials from the Orange Service Center Council.</b>
<b>2/1/20 – 2/21/20</b>	Preparation of state ballots, biographies, and other election materials.
<b>2/24/20</b>	State Delegate ballots and materials ready for pick up at the Orange RRC.
<b>3/09/20 – 3/13/20</b>	Election in chapters for State Delegates
<b>3/13/20 4:00 p.m.</b>	Deadline for State Delegate ballots, tally sheets, and voter rosters from Chapters to NOCUT office.
<b>3/30 – 4/3/20</b>	Counting of Association ballots. Results announced.
<b>4/6/20 5:00 p.m.</b>	Local and State Delegate election results MUST BE received by the CTA Elections and Credentials Committee, c/o CTA Governance Support Department, PO Box 921, Burlingame, CA 94011-0921 or fax to 650.552.5010. Results must be posted no later than five (5) calendar days following ballot counting.  Deadline for filing a challenge to the election with the Service Center Council and the CTA Elections and Credentials Committee is ten (10) calendar days after the announcement of the election results
<b>4/13/20</b>	<b>Deadline for delegates who have been elected to both Local and State Delegate positions to notify OSCC and their local in writing of the position accepted. (<i>delegates may not hold both positions</i>).</b>
<b>4/20/20</b>	Service Center Council Chairperson must notify CTA of names of successor state delegates if an elected state delegate chooses to go as a local delegate.
<b>6/1/20</b>	Deadline for filing an appeal of the CTA Board of Directors decision on a challenge with the NEA Credentials Committee regarding alleged violations of election requirements.
